Your body is unique. Unique for its strengths, weaknesses, and ability to overcome disease. This is why you need a personalized approach to wellness.

Your health is determined by balance - balance among nerves, hormones, and organ systems. This balance is affected by genetics, lifestyle, emotional state, and environment. Imbalances give rise to diseases that can be difficult to explain, much less treat.

Endobiogeny is an innovative approach to wellness that identifies the imbalances that are causing your suffering. It focuses on the cause of disease, not just symptoms. It explains why repeated stresses to the body or mind can lead to illness and why emotions have such a powerful impact on health. It also explains why certain people are prone to develop certain diseases.

A complete endobiogenic evaluation utilizes the following:

- 1) A detailed health history questionnaire that helps identify inherent weaknesses as well as environmental and social factors that affect your health.
- 2) **Biology of Functions** analysis: an intricate, computerized analysis of labwork that identifies imbalances in the nervous and hormonal systems. It also detects risks for future illness.
- 3) A detailed 30 point physical exam: this comprehensive exam performed by a specially trained physician will reveal the subtle and overt physical manifestations of your hormonal function.

After extensive analysis, a personalized treatment plan will be developed. Treatments will consist of herbs, essential oils, dietary supplements, and lifestyle changes. We acknowledge that traditional medicines are sometimes necessary, but in our experience many patients drastically decrease or completely stop their prescription medicines after endobiogenic treatment. Our goal is to empower you to revive your own natural healing abilities and achieve a better quality of life. We know that you only have one body, and our mission is to enable you to attain all the energy, happiness, and vitality of which your body is capable.

What are the costs? (Please read carefully)

Your **physical exam** will be performed by Laramie Wheeler, D.O. or Jean Bokelmann, M.D. The Physician's fee, which is a separate charge from your endobiogenic evaluation can be billed to most insurance carriers upon request. Applicable patient co-pays and deductibles are due at the time of service. Any portion of the fee not paid by your insurance carrier is your responsibility. (Sorry, we cannot accept Medicare/Medicaid, however we do offer a cash discount).

- **Dr. Laramie Wheeler** is currently seeing patients on **Mondays** except for holidays.
- **Dr. Jean Bokelmann** is currently seeing patients on **Wednesdays and Fridays**.
- ***Dr. Jean Claude Lapraz** comes from Paris, France to the USA 3-4 times per year to see patients at EIMC.

Endobiogenic Evaluation (highly encouraged, but not required)

- **Level 1: \$300.00 (prepaid out of pocket).** This fee includes the following:
 - Extensive lab work performed at your local LabCorp including: CBC, TSH, LDH, CPK, Osteocalcin, Alkaline Phosphatase with Hepatic, Bone, Intestinal Isoenzymes, ESR, Lipid Panel; PSA for men 40 and over (over \$700.00 value!)
 - Processing your lab results through the *Biology of Functions* software (summary printout included).
 - Recommendations for supplements, dietary and lifestyle changes by our Endobiogeny team (Dr. Laramie Wheeler and/or Dr. Jean Bokelmann, Annette Davis, CN).
 - The physical exam fee is NOT included (see above).
 - A follow-up clinic visit is recommended at 3 months.

- **Level 1 Remote: \$350.00 (prepaid out of pocket).** While a face-to-face visit is preferred, we understand that travel is not always medically feasible. We therefore offer preliminary distance evaluations. Before your labs are drawn, you will be required to sign a declaration of informed consent which includes authorization for us to send critical information such as lab alerts to your primary care provider. We suggest that you schedule a face-to-face visit as soon you are able. The fee includes the following:
 - Extensive lab work performed at your local LabCorp including: CBC, TSH, LDH, CPK, Osteocalcin, Alkaline Phosphatase with Hepatic, Bone, Intestinal Isoenzymes, ESR, Lipid Panel; PSA for men 40 and over (over \$500.00 value!)
 - Processing your lab results through the French *Biology of Functions* software (summary printout included).
 - Recommendations for supplements, dietary and lifestyle changes by our Endobiogeny team.
 - A telephone appointment to review your results.

- For personal consultations with ***Dr. Lapraz**, please call for details and pricing.

- **Labs.** Please call for a lab order at least 2 weeks prior to your appointment so that your *Biology of Functions* report can be ready for review. **A 12 hour fast is required prior to your draw (you may drink water and take any required medications).** If applicable, any additional labs ordered will incur a separate fee.

- **Herbs & Supplements.** EIMC does not sell supplements at this time. Please contact Time Laboratories 208-232-5250 (toll free 877-846-3522) to purchase your herbs and supplements. Most insurance providers do not cover the cost of supplements.

**Note: Dr. Lapraz, the co-innovator of Endobiogeny, is a French licensed Medical Doctor. He is not an Idaho licensed M.D. or D.O. He comes to EIMC as a guest consultant to provide natural health care services as defined by and in compliance with Idaho Statutes sections 54-1804. Although Endobiogeny and Biology of Functions have been studied closely and extensively in France, they have not yet been subjected to the requirements of scientific scrutiny according to American medical standards. However, since herbs and supplements are available over-the-counter to all Americans, it is our belief that patients are serving themselves well by undergoing an endobiogenic evaluation to assist them in selecting herb and supplement therapy with the greatest potential benefit and the least potential risk to them as unique individuals.*
